Receive FREE, USDA-funded, healthy meals!

Meals are free to children and teens ages 18 years and under as well as to persons up to age 26 who are enrolled in an educational program for the mentally or physically disabled that is recognized by a state or local public agency. All meals must be eaten onsite and the child must be present to receive the free meal.


